5. Lessee agrees that the space **WILL NOT BE USED FOR** Living/Residential purposes for any length of time. Lessee will not do any kind of mechanical work on property stored at the facility. Changing of flat tires/replacing tires and batteries is accepted.

- 6. Lessee can select a 6 month or 12 month lease for a set discount. The selection of either will require the terms of the lease to be a minimum of time selected and cannot be broken early. If a Lessee wishes to sublet or transfer space during the exiting lease, new Lessee will need to complete a lease agreement and sign an amendment to confirm rental of at least the remaining months. Upon completion of the original Lease term, Lease will automatically continue as a Monthly Lease.
- 7. Any **MONTHLY** Lessee can terminate this contract with a 30 day written notice. Any termination of this lease without property removal will result in a \$10 per day fee incurred starting day 1 following the last fully paid month. Any remaining deposit will not be returned.
- 8. Deposit of 1 months rent is required to reserve space. This deposit can be applied to your final payment and/or returned once all items are removed.
